Preamble

United Nations Human Rights Council is currently navigating a critical phase, facing limitations in its influence and struggling to fulfill its fundamental tasks as outlined in General Assembly resolution 60/251. If this situation persists, it may undermine the Council's utility as an international mechanism for the protection and promotion of human rights. However, reforming this vital structure requires the determination and political will of the Council's member states, as well as that of the United Nations as a whole.

When former UN Secretary-General Kofi Annan proposed the establishment of a Human Rights Council in 2005, aimed at replacing the discredited Commission on Human Rights, he could not foresee that the Council would confront similar challenges nearly two decades later. Evidence of the Council's declining effectiveness is apparent through issues such as non-competitive elections, double standards among member states, and a lack of adequate funding, all of which adversely affect its efficiency. As of December 31, 2022, 123 countries have served on the Council, reflecting its diverse membership. Yet, approximately 70 countries remain hesitant to seek membership, indicating a lack of recognition of its value.

Despite these challenges, there is hope for preserving the gains achieved since the Council's establishment. The momentum created by the adoption of the Charter for the Future under General Assembly resolution 79/1, which emphasizes the Council's role in fostering a safe environment for human rights protection, is encouraging. Additionally, the four resolutions on women's rights adopted during the 56th session of the Council represent significant steps toward preventing violence and discrimination against women, demonstrating the Council's commitment to furthering women's rights.

The launch of "Human Rights Council Member States Index" is a culmination of extensive discussions and in-depth research by **Maat for Peace, Development and Human Rights**. This index is informed by Maat's consistent participation in the Council's activities since obtaining consultative status with UN Economic and Social Council in 2016. The index is designed to be flexible, allowing for updates based on technical feedback or proposals.

This index aims to evaluate the performance of member states of the Human Rights Council and measure effectiveness of their commitment to international human rights standards. The focus is on the performance of member states, as they are the main actors in international relations, which played a pivotal role in drafting international human rights instruments. However, we find that some states have begun to deviate from these commitments, which imposes the need for an objective and effective assessment tool such as this index.

We hope this indicator will enhance the performance of member states within the Council and increase the effectiveness of this body in promoting and protecting human rights globally. Addressing the structural and financial challenges confronting the Council, alongside enhancing funding for its human rights initiatives, will contribute to improved efficiency and benefit all international communities.

In closing, I hope to move away from my previous sentiment regarding the Council's limitations—specifically, that "the Council does not have sticks for those who disobey"—and instead embrace the hope that the Council will transcend its current challenges and play a pivotal role in advancing human rights, free from politicization and double standards.

Introduction

Human Rights Council is an international body affiliated with the United Nations General Assembly, tasked with promoting and protecting human rights and fundamental freedoms globally. Established on March 15, 2006, by General Assembly Resolution No. 60/251, it replaced the Human Rights Commission after former Secretary-General Kofi Annan recognized the latter's declining performance and credibility, which adversely affected the United Nations' reputation. The creation of the Council was part of broader reform efforts within the organization.

Comprising 47 member states elected by General Assembly through secret ballot, the Council's membership reflects a fair geographical distribution among the regional groups recognized by United Nations. Each member serves a three-year term and may not be re-elected directly after two consecutive terms. General Assembly retains the authority to suspend the membership of any state committing serious human rights violations, as demonstrated in rare cases involving Libya and Russia.

As a subsidiary body of General Assembly, the Human Rights Council is subject to evaluation before the end of 2026, with the potential for greater independence. Maat supports this evaluation, believing it could positively impact the Council independence and efficiency.

The Council establishment raised significant hopes, particularly among civil society organizations, as it was seen as an opportunity to improve the global human rights situation and achieve a better balance among the UN's three pillars: human rights, peace and security, and development. However, nearly two decades after its inception, the Council has yet to realize its goals, facing limitations in influence and shortcomings in member performance.

In this context, Maat recognizes the need for indicators to measure the effectiveness of member states within the Council, aiming to prevent the use of membership solely as a means to enhance external image. Maat has developed five sub-indicators to evaluate member performance, serving as a foundational tool to assess the Council progress in fulfilling its mandate. These indicators seek to enhance the Council's effectiveness and address the gaps that hinder its operations, especially in light of the increasing challenges to human rights worldwide.



Why This Indicator?

Human Rights Council serves as the primary body for promoting human rights on an international scale. Consequently, it garners significant attention from civil society organizations, particularly those with consultative status linked to the Economic and Social Council. This interest extends beyond mere participation in the Council's activities; it encompasses monitoring the performance of its 47 member states and identifying challenges that affect the Council efficiency and effectiveness.

Maat observation of Human Rights Council sessions has revealed that some countries exploit their membership to project a misleading image of their human rights records or to deflect criticism while unjustly criticizing others. In response, Maat has developed this index to evaluate the performance of Council member states. It considers the motivations behind these countries' nominations and their interactions during various Council sessions.

The index first edition covers three sessions of the Human Rights Council in 2024: 55th Regular Session: 26 February - 5 April 2024; 56th Regular Session: 18 June - 12 July 2024; 57th Regular Session: 9 September - 11 October 2024.

Objectives of Index:

- Evaluate performance of member states and their adherence to voluntary pledges.
- Identify gaps that hinder Human Rights Council efficiency.
- Propose initiatives to address shortcomings in the Council operations.
- Highlight disparities in member states' performance based on UN geographical classification.
- Provide practical recommendations to encourage member states to implement improvements.



Factors Facilitating Preparation of This Index

- Nearly two decades of accumulated experience by Maat in engaging with international human rights mechanisms.
- Capability to apply sub-indicators and related elements consistently across all member states.
- Access to objective, evidence-based information regarding the performance of Human Rights Council member states.

Methodology

The Index of Member States of the Human Rights Council employs a methodology based on five core sub-indicators, along with additional criteria to assess the performance and effectiveness of the 47 member states.

The criterion of reporting to treaty bodies was excluded from index, as the Council is a non-contractual mechanism.

First Sub-Indicator: Sponsorship of Resolutions

Each member state is awarded: 5 points for submitting three or more draft resolutions that gain the confidence of a majority of members or for serving as a primary sponsor of these resolutions. An additional 15 points if the total number of resolutions submitted or sponsored exceeds six. A total of 20 points if the number exceeds seven. It is the total number of full points that can be achieved according to the first sub-indicator.



Second Sub-Indicator: Active Participation in Council

Participation in Council sessions is a key indicator of member engagement. Therefore, the index will award 15 points to each country that participates in more than 30 oral statements in the Council annual regular sessions:

- 20 points for participation with 50 or more oral statements.
- 15 points for participation with 30 to 49 oral statements.
- 0 points for participation with fewer than 30 oral statements.

Third Sub-indicator: Voluntary Pledges and Positive Initiatives

Under Human Rights Council resolution 60/251, voluntary pledges made by member states prior to candidacy are considered valuable. The points system is as follows:

- 5 points for each state that submits voluntary pledges prior to membership.
- 5 points for each country that interacts once with special procedures during the reporting period (e.g., requesting or accepting a visit).
- 10 points for countries that interact more than once (e.g., requesting or accepting two visits).
- 5 additional points for positive interactions with communications received from special procedures.

The total possible points for this sub-indicator is 20 points. If a country does not receive communications from special procedures, it will still receive the 5 points allocated for its voluntary pledges, indicating that the human rights situation may not require intervention.

Fourth Sub-indicator: Contribution to United Nations Budget

Each member state is required to pay its share of the UN's regular budget, as outlined in Article 17, Chapter IV, paragraph 2 of the UN Charter. Contributions finance the human rights pillar and the activities of the Office of the High Commissioner for Human Rights. The points system is as follows:

- 20 points for timely submission of assessed contributions.
- **10 points** for late submission of contributions that are eventually paid.
- 0 points for failure to pay contributions.

This sub-indicator aims to reflect the financial commitment of member states to the UN human rights agenda.

Fifth Sub-Indicator: Country Contribution to Promotion of Human Rights

According to Human Rights Council Resolution No. 60/251, member states must consider the contribution of candidate states to the promotion of human rights when selecting members of the Council. The sub-requirements to achieve full points under this indicator are as follows:

- **5 points** if the country has a national human rights strategy or plan.
- **5 points** if the country has a parliament elected by the people.
- **5 points** if the country accepted more than 75% of the recommendations presented during its last review in the review mechanism.
- **5 points** if the country has a national human rights institution that complies with the Paris Principles.

Maat evaluated the effectiveness of member states in the Human Rights Council based on the total points earned by each country.

Key Findings

- Member States voted on 91 resolutions during the three sessions of the Human Rights Council in 2024. The 57th session saw the highest number of resolutions adopted at 37, followed by the 56th session with 32 resolutions, and only 22 resolutions in the 55th session.
- Forty-seven Member States participated with oral statements across the three sessions in 2024. Without the support from the Trust Fund for the Participation of Least Developed Countries and Small Island Developing States, established in 2012, six Member States would not have been able to participate.

- Among the Member States that paid their assessed contributions, seven countries had not paid their share by the due date of February 8, 2024. This includes four countries from the African Group, two from the Latin American and Caribbean Group, and the United States from the Western Europe and Other Group. Notably, the United States, which is the largest contributor to UN budget, with a share of 22% of the total budget according to the latest estimates for 2023, has not paid its share of the UN budget in 2024.
- Forty member states contributed \$1.831 billion to the United Nations regular budget in 2024, out of a total of \$3.6 billion of total regular budget of United Nations, excluding the peacekeeping budget and certain other activities funded outside regular budget. Contributions from member states to the Council represent 51% of the total regular budget
- United States received the most communications from the special procedures, totalling 73 in 2024, but responded to only 22, accounting for 30.1% of the total communications. Consequently, it did not earn any points for positively interacting with the communications received.
- Gambia and Morocco achieved the highest scores in the African group, with 80 and 65 points, respectively, marking Gambia's performance as highly effective and Morocco's as effective.

- In 2024, 42 member states of the Human Rights Council made voluntary pledges upon their nomination. Notably, the five countries that did not submit voluntary pledges—Benin, Burundi, Gambia, Ghana, and Somalia—are all from the African group.
- Indonesia, a member state, partnered with a non-member state in 2024 to rationalize initiatives and activities arising from resolutions adopted by the Human Rights Council. However, this direction only minimally reduced the number of initiatives and activities.
- The participation of least developed countries and small island developing states in the Council remains weak, largely due to limited resources, hindering their representation.
- Some member states, including Ghana and Paraguay, emphasized the value of human rights mechanisms and their role in fulfilling international obligations during the Council sessions in 2024.
- Countries from the Global South, particularly those in the African Group, prioritized discussions on economic and social rights. In contrast, Western European countries focused primarily on civil and political rights, with the United States also emphasizing civil and political rights.
- Member states acknowledged the crucial role of the Voluntary Fund for the Universal Periodic Review in providing financial and technical assistance, along with the United Nations Voluntary Fund for Technical Cooperation in the Field of Human Rights.
- Item 10 of the Council's agenda received widespread agreement among member states, calling for the Office of the High Commissioner for Human Rights to provide technical assistance and capacity building as needed.
- Seven member states contributed to the adoption of resolution A/HRC/RES/56/5 on July 10, 2024, establishing an open-ended intergovernmental working group on an optional protocol to the Convention on the Rights of the Child, focusing on the right to early childhood education, free pre-primary education, and free secondary education. The contributing states are Luxembourg, Bulgaria, the Dominican Republic, Gambia, Kazakhstan, Kyrgyzstan, and Romania.

First: Performance of States According to Five Sub-Indicators




1. Performance of States According to Sub-Indicator I: Sponsorship of Resolutions

In 2024, Member States of the Human Rights Council adopted a total of 91 resolutions across three sessions. The breakdown of resolutions shows that the 57th session was the most productive, with 37 resolutions adopted, followed by the 56th session with 32 resolutions, and the 55th session, which saw only 22 resolutions.




Figure (1): Number of Decisions Approved in Council Sessions for 2024




Gambia emerged as the member state that sponsored the most draft resolutions, contributing 12 resolutions, distributed as an average of four resolutions per session. Germany followed closely, sponsoring 10 resolutions, while Brazil and Belgium each sponsored eight resolutions.

Notably, eight member states did not serve as main sponsors for any draft resolutions during the three sessions. These countries included five from the African Group and three from the Asia-Pacific region: Vietnam, India, and Kuwait.

Overall, 39 out of the 47 member states were main sponsors of resolutions during the sessions, indicating a significant level of engagement among many countries. The table below shows the number of resolutions sponsored by Member States during 2024

2. Performance of States According to Sub-Indicator II: Effective Participation

Member States participated in the Human Rights Council with approximately 3,144 oral statements during the sessions in 2024. The 55th session had the highest participation rate, with around 1,163 oral statements, while the 56th session recorded the lowest participation, with approximately 960 oral statements. In the 57th session, member states submitted 1,021 oral statements, either from within the Council or remotely.





Figure (4): Member States Participation in Human Rights Council Sessions

Countries from the Asia-Pacific geographical region led in participation, contributing about 1,012 oral statements, followed by the African Group with around 846 statements. European and Others geographical group provided about 532 statements, while the Latin America and Caribbean group submitted approximately 471 statements. Eastern European regional group contributed the least, with about 281 oral statements.




Figure (5): Geographical Distribution of Member States Participation in Council Sessions



All member states of the Human Rights Council participated in 2024, with China taking the lead by submitting 188 oral statements across the three sessions. It was followed by Cuba, the United States, and India. As shown in Figure 6 below.

In contrast, Somalia had the least participation in 2024, contributing only five statements throughout the three sessions. Additionally, Eastern European Group was identified as the least participating regional group. The table shows the number of participations of all member states distributed according to the three sessions of the Human Rights Council.

3. Performance of Countries According to Third Sub-Indicator: Voluntary Pledges and Positive Initiatives

According to United Nations General Assembly Resolution No. 60/251, which established the Human Rights Council, the voluntary pledges submitted by each country before its candidacy for membership are considered during the nomination process. These voluntary pledges serve as an additional advantage for countries seeking membership, as they reflect a commitment to protecting and promoting human rights. Typically, these pledges are prepared and sent by a country's Permanent Mission to the United Nations in a note verbale addressed to the President of the General Assembly. The contents often highlight the country contributions, achievements, and commitments in the realm of human rights. Subsequently, these notes verbale are circulated as official documents of General Assembly. In 2024, 42 member states of Human Rights Council included in the index submitted voluntary pledges when nominated for membership. However, it is important to note that five countries within the African Group—Benin, Burundi, Gambia, Ghana, and Somalia—did not submit any voluntary pledges.


3.1 Interaction with Country Visits

In 2024, 21 member states of the Human Rights Council engaged with mandate holders under the UN special procedures, which is less than half of the Council total membership. Brazil, Kuwait, and Chile were the most active, each having three interactions with special procedures.



2.3 Engagement with Communications from Special Procedures

During 2024, 36 member states of the Human Rights Council received a total of 227 communications from special procedures, while 11 states did not receive any communications. Among the 36 states that did receive communications, only 28 responded, leaving eight countries that ignored these communications.


Figure (8): Interaction of Member States with Communications Received from Special Procedures



United States was the most frequently communicated with, receiving 73 communications and responding to only 22, which represents 30.1% of the total. China followed with 26 communications, while Argentina, Germany, and France also received notable numbers, as shown in Figure 9 below.

Remarkably, the five countries that received the most communications accounted for 135 communications, representing 59.5% of the total communications received by the 36 member states of the Human Rights Council. This data underscores the varying levels of engagement among member states with special procedures and highlights areas where improvement is needed.



4. Performance of Countries According to Fourth Sub-Indicator: Contribution to Budget

Of the 47 member states of the Human Rights Council, only 14 countries paid their due contributions to the human rights budget in 2024, representing approximately 29.8% of the total membership. In contrast, 26 countries failed to pay their contributions by the deadline of February 8, 2024.





Additionally, there were seven other countries that did not contribute to the United Nations budget, thereby affecting the financing of the human rights pillar and the activities of the Office of the High Commissioner for Human Rights, which serves as the Council secretariat.

Two significant observations arise from this data. First, among the member states that did provide the required contributions to the regular United Nations budget, seven countries failed to pay their shares. This group includes four countries from the African Group, two from the Latin American and Caribbean Geographical Group, and the United States from the Western European and Others Geographical Group. Second, it is noteworthy that the United States, the largest contributor to the United Nations budget with an estimated share of 22% of the total regular budget, did not fulfill its payment obligations in 2024.

1. Performance of States According to Fifth Sub-Indicator: Contribution to Promotion of Human Rights

The fifth sub-indicator identifies four criteria that member states must achieve to demonstrate their contribution to the promotion of human rights during their tenure in the Council. These criteria are: the adoption of national human rights strategies and plans; the existence of an elected legislative body; the acceptance of more than 75% of recommendations within the Universal Periodic Review mechanism; and the establishment of a national human rights institution compliant with the Paris Principles. Contributing to the promotion of human rights involves various measures, including the adoption of national strategies and plans that set ambitious goals to be achieved within specific time frames. The presence of an elected legislative body is crucial, as it allows for the proposal and approval of legislation that addresses human rights issues. Additionally, fulfilling pledges accepted during the Universal Periodic Review adds significant value to a state's efforts to promote fundamental rights and freedoms. Moreover, having a national human rights institution that complies with the Paris Principles is an effective tool for monitoring human rights development and identifying challenges faced by government institutions in meeting their obligations. The table below shows the position of countries on the four sub-criteria set by the index to measure the country contribution to promoting human rights.

According to the index measuring countries' contributions to promoting human rights, out of the 47 member states, 22 have yet to issue national human rights strategies and action plans. Eighteen countries have a national plan but have not updated it, while only seven countries, representing 14.9% of the total member states, have adopted national human rights strategies. As indicated by the data from the 47 member states of the Council, 42 countries have a legislative body elected by their citizens, while 5 countries lack such a body. The reasons for the absence of elected legislative bodies vary from country to country. Table Nine illustrates the member states of the Human Rights Council that do not have an elected legislative body.

Regarding compliance with the Paris Principles, it is noted that only 28 member states possess a national human rights institution classified as (A) by the Global Alliance of National Human Rights Institutions. This classification indicates that these institutions comply with the principles relating to the status of national human rights institutions. In contrast, 6 countries have institutions classified as (B), while 13 countries do not have any national human rights institution that meets the criteria for either classification.

Furthermore, it is evident that among the member states of the Council, 35 countries exceeded 75% in the acceptance of recommendations during their last review under the Universal Periodic Review mechanism. However, 12 countries did not meet this threshold, resulting in a loss of points allocated according to this fifth sub-indicator. Table 10 outlines the recommendations submitted to each country and the number of recommendations fully accepted during their most recent review.


Second: Geographical Classification of Performance of Member States in Human Rights Council



The membership of the Human Rights Council is based on a fair geographical distribution as established by the United Nations. Consequently, Council seats are allocated as follows: 13 seats for African countries, 13 for Asian countries, 8 for Latin America and the Caribbean, 7 for Western Europe and other countries, and 6 for Eastern Europe.

In terms of activity within the Council, member states from the Western Europe and Others Group were the most active, drafting and sponsoring a total of 44 resolutions during the three sessions. Latin American and Caribbean countries followed with approximately 36 resolutions, while Asia-Pacific countries sponsored about 29 resolutions. African countries contributed around 28 resolutions, making them less active compared to their Western counterparts. Lastly, countries from Eastern Europe were among the least active, sponsoring only about 16 resolutions in the Human Rights Council throughout 2024. The accompanying figure illustrates the number of resolutions sponsored by each geographical group, highlighting the differences in engagement levels among the regions.

In 2024, all Member States made a total of 3,144 oral statements during the three sessions of the Human Rights Council. The geographical group of Asia and the Pacific was the most active, contributing significantly to these statements, with three countries—China, India, and the Maldives—accounting for 40.2% of the total oral statements from this region. Conversely, Eastern European countries made the fewest oral statements during the year.

The data indicates that 42 Member States of the Human Rights Council made voluntary pledges when they applied for Council membership, while only five countries did not submit such pledges, all of which belong to the African regional group. Additionally, 21 countries responded to country visits by special procedures, whereas 26 member states did not provide any response in 2024. In terms of engagement with communications from special procedures, 24 countries responded, while 23 countries remained unresponsive.

Regarding contributions to the budget, there was a notable convergence among geographical groups concerning the timely payment of regular budget shares to the United Nations. Five countries from the Western Europe and Others Group paid their contributions on time, alongside four countries from Asia and the Pacific and three from the African Group. A key observation is that the United States, which holds the largest share of the regular budget, did not fulfill its payment obligations in 2024. The accompanying table illustrates the contributions of various countries to United Nations budget and the human rights pillar.

When examining the classification of countries based on the fifth sub-indicator, which measures contributions to the promotion of human rights, it is evident that countries in the Asia-Pacific region have adopted the most national human rights plans. In contrast, African countries have the highest number of elected legislatures, and these countries also accepted more than 75% of the recommendations in their last review under the Universal Periodic Review mechanism. The table provides a geographical classification of these three criteria within the fifth sub-indicator.

Priority Recommendations

Maat recommends that Member States:

- Consider launching campaigns to urge UN General Assembly to make the Human Rights
 Council an independent body. General Assembly should be encouraged to take serious
 steps toward transforming the Human Rights Council into an independent entity during the
 evaluation scheduled for 2025-2026. This transformation would enhance the Council's
 effectiveness and independence in addressing human rights issues.
- Maat recommends that States consider establishing national human rights institutions
 that are fully compliant with the Paris Principles. It is essential for countries to create
 institutions that rigorously adhere to these principles to ensure their independence and
 effectiveness in protecting human rights.
- Strengthening cooperation between Member States and civil society is crucial: Effective collaboration should be expanded during and after the term of States' membership in the Council to facilitate knowledge exchange and enhance transparency in addressing human rights issues.
- Studying and analyzing proposals submitted by civil society and human rights experts: Member States of the Council shall study and analyze the proposals of civil society and human rights experts practice aims to improve and develop the Council performance in promoting human rights on a global scale.
- Increase support for High Commissioner for Human Rights: It is necessary for the council member states to avoid the use of double standards or politicization in their interventions during the council's sessions, to ensure that discussions on human rights are objective, fair, and comprehensive.
- Avoiding duality of standards and politics in interference: Member States should avoid double standards and politicization in their interventions during Council sessions. Ensuring that discussions on human rights are objective, fair, and comprehensive is crucial for the integrity of the Council's work.
- Study preparation of national human rights strategies and plans: States should work to
 develop ambitious national strategies and action plans that enhance the protection of
 human rights within their territories. Setting clear and measurable goals will help ensure
 continued progress in this area.
- **Promoting human rights education and awareness initiatives:** Member states of the Council must enhance educational and awareness initiatives of human rights at the level of the interior and abroad, which enhances the understanding of human rights and the commitment of states to its principles.
- Encouraging States to adhere to international human rights mechanisms: It is necessary to encourage countries to adhere to international human rights treaties and mechanisms, such as includes submitting regular reports to relevant UN bodies and participating in periodic reviews, which contribute to accountability and transparency.



- Enhancing youth participation in human rights issues should be prioritized: Encouraging the involvement of young people in the Council's discussions and decision-making processes is important for fostering a new generation of human rights defenders.
- Expanding accountability mechanisms for Council member states: Strengthening these mechanisms will ensure that member states adhere to their commitments to protect human rights and effectively implement international recommendations.
